The Appointments Committee of the Cabinet has approved the following appointments /premature repatriation of officers at Joint Secretary / Joint Secretary equivalent level with pay at Level 14 of the Pay Matrix :

- (i) Appointment of **Shri Sachidanand Prasad, IP&TA&FS (1994)**, as **Secretary, National Commission for Indian System of Medicine (NCISM)** under the **Ministry of AYUSH**, from the date of assumption of charge of the post, for a tenure upto the date of his superannuation on 31/12/2027 or until further orders, whichever is earlier. - (vi) Appointment of **Shri Pankaj Yadav, IAS(HY:2001)**, as **Joint Secretary, Department of Rural Development**, from the date of assumption of charge of the post, for an overall tenure of five years upto 31/10/2027 or until further orders, whichever is earlier, *vice* Shri Karma Zimpa Bhutia, IFoS (JH:1997);

(vii) Appointment of **Shri Vinod Kumar Tripathi, IRSE (Civil) (1995)**, as **Joint Secretary, Ministry of Steel**, from the date of assumption of charge of the post, for a tenure upto the date of his superannuation on 31/12/2027 or until further orders, whichever is earlier, *vice* Ms. Ruchika Chaudhry Govil, IRS (IT:1990);
